Letter Ballot 12 started on December 10, 1997, as soon as the Standards Board had approved the 2 related PARs: 802.11c and 802.11. Documentation was submitted before that time, so was already available at members desks. The ballot closed on January 12, but, due to e-mail gateway problems in the week-end, I accepted the ballots coming in on Tuesday as well.

Motion 1: **To approve document IEEE 802.11c/D1.1 for submission to Sponsor Ballot,**  
votes returned: 47. 42 were from voting members.  
Total result: 40 approving, 4 disapproving, 3 abstaining.

Voting members: 36 approving, 4 disapproving and 2 abstaining.  
From 52 voting members, 42 returned their ballot: 80 %, (50 % required)  
Support for the motion: 36 of 40 members = 90 %. (75 % required)  
**Motion passes.**  
Comments are contained in document 98/14.

Next step: Negative votes to be resolved at January meeting, changes need to be recirculated.

Motion 2: **To approve the contents of document 97/154-r2 for submission to Sponsor Ballot, and to approve the proposed responses to interpretation requests in doc. 97/159,**  
votes returned: 47. 42 were from voting members.  
Total result: 33 approving, 5 disapproving, 5 abstaining.

Voting members: 32 approving, 8 disapproving and 2 abstaining.  
From 52 voting members, 42 returned their ballot: 80 %, (50 % required)  
Support for the motion: 32 of 40 members = 80 %. (75 % required)  
**Motion passes.**
